Anyone over the age of 18 and camping overnight will be asked to submit personal information to the Illinois District Assembly of God for a background check. This request will be sent to your e-mail. If you have attended a Ranger Event this year and have had the background check done, you will not receive a request because these checks are good for one year. <u>Please</u> note this is a requirement for adults to attend overnight.

Print a copy of the permission slip for each boy and bring them to Camporee and hand them in at registration. Please bring registration payment to camp if not paid online. Make checks out to: Southern Division Royal Rangers.

Camp set-up will begin Friday morning at 10:00 A.M. Camp dismissal will be around 10:30 A.M. Sunday morning. All game activities will take place on Saturday morning after the morning devotion and announcements. <u>We do not have permission to swim in the lake.</u>
